

# After your mediation or disagreement resolution meeting

## Frequently asked questions

**Q: What if I'm not satisfied with the outcome of mediation?**

**A:** Contact your local Independent Advice and Support Service (IASS), formerly known as Parent Partnership, who will explain how to appeal to the first tier special educational needs and disability tribunal.

**Q: Where can I find information about special educational needs and disability services where I live?**

Every local authority is required to publicise how the needs of disabled children will be met, this is called the Local Offer. You can find information about the Local Offer on your local authority's website. As well as the Local Offer, your local authority will also have a parent forum. **Q: My local authority has agreed to conduct an education, health and care (EHC) assessment for my child. How and when will they contact me? If I don't hear from them, who can help me with this?**

**A:** Contact the school and if you aren't satisfied you can contact your local SEND team, IASS, IPSEA or make a formal complaint through the school complaints process.
